

**BASS PRO SHOPS**  
**“BUY A STAND, BAG A TRUCK” SWEEPSTAKES**  
**OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR CLAIM PRIZE.  
OFFERED ONLY IN THE 50 UNITED STATES OR DISTRICT OF COLUMBIA (“U.S.”)  
AND OPEN ONLY TO LEGAL U.S. RESIDENTS WHO ARE 18 YEARS OF AGE OR OLDER.

1. **ELIGIBILITY:** NO PURCHASE NECESSARY TO ENTER OR CLAIM PRIZE. Open to legal residents of the 50 United States or District of Columbia who are 18 years of age or older at time of entry. Employees of Bass Pro Trademarks, L.L.C. (the “Sponsor”), Out O’ Site LLC, their respective subsidiaries, agencies, affiliates, participating retailers, and members of the immediate families (spouses and parents, siblings, children and their spouses and in-laws) and persons living in the same household of such individuals (whether related or not) are not eligible. 2. **TO ENTER:** Official entry forms are available at participating stores while supplies last. Or, you may print one at [www.apioutdoors.com](http://www.apioutdoors.com). Or, one will be shipped to you along with your online or catalog order of any API Outdoors treestand or accessory from Bass Pro Shops. To enter the “Buy a Stand, Bag a Truck” Sweepstakes, purchase any API Outdoors treestand or accessory between the dates of 5/15/08 and 12/31/08. Then, complete an official entry form or hand print your name, complete address, daytime phone number, email address and date of birth on a 3” x 5” piece of paper and mail it, along with proof of purchase (UPC from product and a photocopy of your receipt with purchase price circled), to be postmarked by 1/5/09 and received by 1/12/09 to: Bass Pro Shops “Buy a Stand, Bag a Truck” Sweepstakes, PMI Station, PO Box 3592, Southbury, CT 06488-3592.

You may also enter without making a purchase by mailing your entry without proof of purchase.

3. **PRIZES:** On or about 1/15/09, a random drawing will be conducted by Promotion Mechanics, Inc., an independent judging organization, from among all eligible entries received to award the following prizes:
  - (1) First Prize: a 2008 Toyota Tundra 4x4 double cab or 4-door truck, and a 2008 Cub Cadet UTV. Total combined approximate retail value of prize is \$45,000.

Winner will have three months to present valid driver’s license, evidence of insurance and any other information requested by Sponsor. If winner does not take delivery of truck within 3 month period or otherwise fails to satisfy the requirements set forth in these Official Rules, the truck portion of the prize will be forfeited. Winner is responsible for any expenses, insurance and taxes not expressly provided for in these Official Rules. Model, color and accessories will be determined by Sponsor and may vary from that depicted in advertising and promotion materials. Winner is responsible for all taxes, license, title and registration fees, and insurance.

(1) Second Prize: a guided 5 day Whitetail Hunt (winner’s choice of archery, rifle or muzzle loader) for winner at a ranch to be determined by Sponsor, and \$1,500 in Bass Pro Shops gift cards. Prize consists of round trip coach-class air transportation, ground transportation to/from the airport and ranch, 5 days’ accommodations, and guided service. Total combined ARV \$11,500, however, actual value will be determined by winner’s residence and seasonal rates. By participating, entrants (and entrant’s parent/legal guardian if entrant is a minor in his/her jurisdiction of

residence) agree (a) to these rules and decisions of judges which shall be final in all respects; (b) to release and hold harmless Sponsor, Out O' Site LLC, their respective subsidiaries, affiliates and agencies, including Promotion Mechanics, Inc., and their respective directors, officers, employees, agents and representatives from any and all claims, demands, costs, expenses, liability, losses or damages of any kind resulting from their participation in the promotion or their acceptance, use or misuse of a prize, including liability for personal injury or death; (c) if a winner, to the use of name and/or photograph for advertising and publicity purposes without compensation (unless prohibited by law) and to execute specific consent to such use if asked to do so, and to the announcement of their name, city and state; and (d) that Sponsor and its agents have not made any representation, warranty or guaranty, in whole or in part, in law or in fact, relative to the prize.
